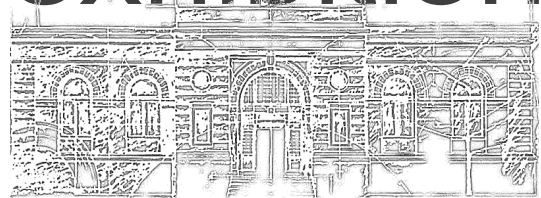

This juried exhibition is an opportunity for emerging and established artists to exhibit their work in a professional gallery setting at the historic Carnegie Art Center.

ENTRY INFORMATION

- Open to any artist 18 or older from any geographic residence.
- Entry forms may be picked up at the Carnegie or at thecarnegiemankato.com.
- Artwork is to be dropped off with completed entry form, in person, Saturday March 25, 3-5 pm. at the Carnegie Art Center, 120 South Broad Street, Mankato.
- Entry Fee is \$10 per piece, nonrefundable, with a 3 piece limit.
- Cash or Check payable to: Carnegie Art Center.

OPENING RECEPTION AND AWARDS

- **One, \$200 "Elspeth Cook Carlstrom Award"** in memory of artist, arts advocate, and friend. Sponsored by the Cook-Carlstrom family.
- **Five, \$200 "Carnegie Awards of Excellence"** will be presented to juror-selected artists at the reception, Saturday, April 22, 7-9 pm. We invite the public, family and friends of the artists to the Opening Reception in the historic Carnegie Art Center, at 120 South Broad, Mankato.

SPECIFICATIONS

- Entries must be original 2-D or 3-D artwork completed in the last 4 years.
- Works selected for the exhibition may not be removed prior to the closing date.
- Works juried into previous CAC juried exhibitions are not eligible for entry.

SIZE AND WEIGHT

- 2-D work, 6' x 10' maximum, with 20lb weight limit.
- 3-D hanging pieces, maximum weight of 20 lbs.
- 3-D pedestal and floor pieces, maximum weight of 100 lbs.

PRESENTATION

- All 2-D works on paper must be framed. If matted, neutral colored mats should be used.
- All 2-D paintings and framed pieces, must have eye hooks and wire installed in order to be submitted. Sawtooth hangers are acceptable on small pieces or when part of a framing system.
- Installation pieces or works that require electricity will only be accepted with consideration of the gallery space.

JUROR NOTIFICATION AND RETURN OF WORK

- An impartial juror will be selected.
- All participants will be notified of the juror's decision by mail on or before Friday, March 31.
- Pickup of declined work: Saturday April 1, 3-5 pm.
- Pickup of exhibited work: Saturday May 20, 5-7pm.
- A person other than the artist may pick up work on the designated dates, if they have the Receipt Card and ID.

LIABILITY

- Insurance coverage is provided only for works juried into the exhibition, March 25 - May 20, 2017. The Carnegie Art Center will respectfully handle and care for all work entered, however, it is not responsible for loss or damage before or after this period. See waiver on entry form.

SALE OF WORK

- The Carnegie receives a commission of 30% of any work sold from the exhibition. The artist will receive payment of 70% of the selling price at the end of the exhibition. The Carnegie will contact the purchaser with pickup date at the close of the exhibition.
